


Figure 1. Cloud environment architecture




Figure 2. UML Use-Case Diagram




Figure 3. UML Sequence Diagram




Figure 4. Symmetric Encryption




Figure 5. Asymmetric Encryption




Figure 6. Remote auditing mechanism
